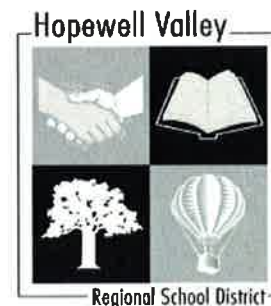

URGENT ATTENTION NEEDED – RESPONSE NECESSARY BY JUNE 8, 2012

HAZARDOUS SUBSCRIPTION BUS SERVICE FOR 2012-2013

May 11, 2012

Dear Parent/Guardian:

As part of an overall strategy to balance the school district budget within State-imposed caps, the Board of Education eliminated hazardous busing for secondary students who live less than two miles from school, which is less than the statutory limit of 2.5 miles for mandated busing. *Board Policy 8600 Pupil Transportation* may be viewed on the district website, www.hvrtd.org, by using the *Board of Education* and then *Board Policies* links.

Your home address is one that was deemed ineligible for transportation under Board Policy 8600. As we have done in the past, the Board is prepared to assist parents who are interested in parent-paid transportation for students by arranging for subscription bus service. Essentially, this would mean paying for a seat for your child for the year. The cost for this option would be \$150 per child up to the family cap of \$300.

As was the case this year, the Board anticipates that a police officer will remain assigned to help students cross Rt. 31 at the Delaware Avenue traffic light.

If you are interested in this service, please return the enclosed application form for Hazardous Subscription Bus Service with payment (see payment instructions at the bottom of the application form) to the attention of Mrs. Louise Colanduoni before **June 8, 2012**. **This information is needed to solicit quotes for transportation services for the 2012-2013 school year. Please note that the Transportation Department may not be able to guarantee that a seat will be available for your child if a request is received after this deadline.**

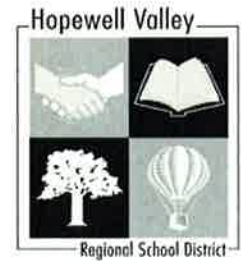
