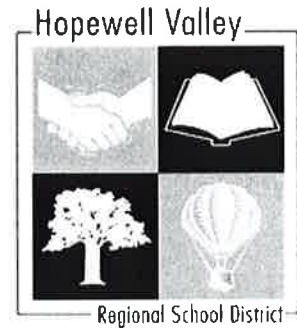

2011-2012 Extracurricular Activities Fee

Dear Parent/Guardian:

The Board of Education is asking participants to supplement the cost for the extracurricular activities on the attached list. Students who wish to participate in any of these extracurricular activities are required to pay an annual fee of \$150.00 per child at Central High School and \$75.00 per child at Timberlane Middle School up to the family cap of \$300.00. Students who pay these fees are entitled to participate in one or more programs during the year.

Fees are expected to be paid prior to participation in the first meeting or practice of the extracurricular activity. In all activities where there are "cuts" a student is entitled to a refund if they do not make the "final cut." In addition, payment of the fee does not guarantee any participant playing time. Students who voluntarily drop out of any activity will forfeit their fee. Refunds may be made because of injury, illness, or moving out of the district as follows:

- a. Full refund if less than one-half of the activity season is completed.
- b. No refund if more than one-half of the activity season is completed.
- c. All refunds will be made at the end of the school year.

The Board of Education understands that some families, due to financial hardship, may be unable to pay all or part of the extracurricular fee. It is the intent of the Board that no student is denied the right to participate due to the inability to pay. Should you need an exemption, please contact your building principal who will review your situation and make a determination. This matter will be held confidential.

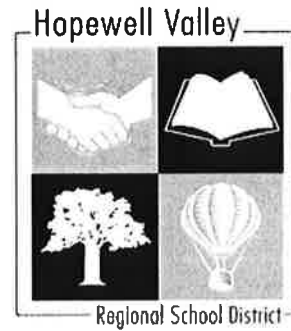

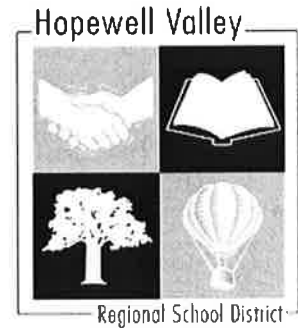
